I hereby understand that each time “Ultimate, Ultimate AllStars” is mentioned throughout this contract it is meant to be all-inclusive of Ultimate Cheer & Dance Inc (577 NW Interpark Pl, Port St Lucie, FL 34986), and its employees/volunteers. This contract is to be initialed and signed by each athlete and their parent. This contract is valid May 2022 through June 1, 2023. Please read thoroughly with your child and initial and sign the bottom of this form.

GENERAL

1. I agree to help keep the gym clean by not bringing food or gum/candy into the practice areas, and by disposing of any trash in the appropriate trash receptacles. GUM is strictly forbidden in the FACILITY.
2. **I AGREE THAT I WILL NOT TAKE PRIVATE LESSONS, CLASSES OR CLINICS AT ANY OTHER CHEER GYM OR DANCE STUDIO.**
3. I agree to use the tumble trak, trampoline and spring floor with a coach’s supervision.
4. I agree that all cell phones must be put on silent or vibrate mode when I am inside the facility.
5. I agree that ULTIMATE is not responsible for any personal items lost or stolen and should therefore refrain from bringing jewelry or other items that I value into the facility.
6. I agree that all decisions made by ULTIMATE are in the best interest of the program and that any differences I may have will only be discussed with the ULTIMATE staff at a scheduled time.
7. I will refrain from gossiping or “talking trash” about any participant, parent, staff, etc., or other programs, as I understand that it can lead to personal conflicts and is therefore not conducive to the success of this program. Such talk may lead to dismissal from the program.
8. Any person or athlete fighting will be asked to leave immediately and may result in being expelled from the gym.
9. **I UNDERSTAND THAT ANY USAGE OF LOGOS OR THE NAME ULTIMATE OR TEAM NAMES AFFILIATED WITH ULTIMATE MUST BE APPROVED BY ULTIMATE.**

HEALTH

1. I agree to provide ULTIMATE with a list of any/all medications that I am currently taking.
2. I agree to notify ULTIMATE and the coaching staff of any and all medical conditions, which may limit or prevent my ability to participate in any Ultimate All-Stars practice or event.
3. I agree to provide valid written documentation from a doctor explaining the reason(s) and the duration for which I am limited or unable to participate in any Ultimate Cheer and Dance All-Stars activities/events.

4. I will report any and all injuries (small and big) to my coaches immediately.

MAKEUP POLICY

Because of our strict student-to-teacher ratio, missed classes will not result in make-up classes, prorated tuition, or refunds. No refunds for classes missed including scheduled holidays.

WHAT TO WEAR

All Athletes should wear athletic clothing. Practice wear needs to be worn during practices. NO chewing gum or dangling jewelry. Hair should be pulled neatly and securely away from the face so that it stays up for the entire class/practice. All students should have activity-appropriate footwear during class. Personal items should be left in cubby holes. Jewelry should not be worn during classes. **PLEASE LEAVE JEWELRY ARTICLES AT HOME.** This facility's staff will not be responsible for ANY items that may be lost or stolen. Be sure your student's personal items are marked with their name.

VIEWING AREA & LOBBY ETIQUETTE

This is for the safety of everyone involved, and for liability reasons. “Lobby Coaching” or “Parent Coaching” is not allowed or tolerated at our program. Ultimate does provide a small viewing area for parents, wishing to remain at the gym during practices and lessons. All parents, siblings and/or friends who choose to stay during practices are required to remain in the viewing area during all practices, classes and lessons. Parents' jobs are to support, encourage, and motivate your children! Leave the Coaching to the Coaches as we leave the Parenting to you! We want to work with you to give the athlete the best chance of success.

SMALL CHILDREN & SIBLINGS

Please note for families who choose to bring younger siblings, they must be kept under your constant supervision, and within your reach. Small children must remain properly behaved, and keep noise at an appropriate level, or they will be asked to leave. No small children are allowed on the spring floors, tumbling equipment, or tumble trak. They must stay in the parent viewing area. This includes athletes that are not participating in their assigned practice time.

PARENT ETIQUETTE & CONDUCT

Ultimate Allstars has implemented a “ZERO TOLERANCE” policy regarding inappropriate parent conduct. Parents who are verbally negative, bullying, derogatory towards any athletes or coaches, loud, overbearing, or distracting will be barred from the gym and/or have their athlete permanently removed from our program. This includes, but is not limited to, actions online, at competitions, and at the gym. Parents who are caught, or reportedly threatening to quit/pull, their athletes from a team for any sort of personal gain/appeasement, will be immediately dismissed from the program.

In some cases, there are occasionally individuals or parents who want to try and spread negativity within our program. Our families are here to watch their child enjoy the sport of competitive cheer, and if you cannot be a part of the positivity, then you will be asked to leave. We will not tolerate negativity and/or gossip to be spread in our program under any circumstances. Parents who have a questions/concern, should speak directly to the owners at an appropriate time, or set up a private meeting. All decisions made regarding athletes training are made with the athlete’s best interest at heart! We place athletes on teams, and in levels, where we feel they will be the most successful.

TRUST THE PROCESS!

ROSTER SELECTION

Rosters for teams are designed to give each team an equal chance for success within their division. Much like other sports, a variety of skills and abilities are necessary to give teams the best opportunity to place high at competitions. We try to match up the athletes as best we can, but please remember that maturity, physical stature, stunting, pyramids, jumps, dance, motions, and age are factors.

Every athlete is placed on a team for a reason – please trust the staff, we assure you that they are highly qualified, experienced, and credentialed to do what they do. This season we will be working harder than ever to push every athlete to improve their skills, even if it means working on skills that are above what is allowed in their current division.

The most common confusion or misconception from parents and athletes relates to tumbling ability. Proper technique is more crucial now than ever to achieve the highest scores. Simply being able to complete a skill without falling to the ground is no longer the standard for when an athlete “has” a certain skill. They must be able to perform it with perfect, or nearly perfect technique. In addition, they must be able to do it consistently, on a spring floor, under pressure, in nearly any scenario. Many athletes and parents greatly overestimate the ability and form of the athlete against the standard. A parent’s version of “my child has a layout” can often be dramatically different from the coaching staff, and this can lead to confusion about team placement.

The second most common misunderstanding comes from dramatically overestimating the importance of tumbling compared to other factors. As previously stated, there are many factors that go into determining the best spot for an athlete, not simply how well they can tumble. We must determine where the athlete will have the best opportunity to show well-rounded skills in the sport. Again, trust the staff. Please note that no athlete has an absolute guarantee of a roster spot on a particular team, nor do they have a right to any particular role or spot in a routine. We attempt to make roster changes as infrequently, and with as much warning as possible. Coaches change formations and stunt groups for a variety of reasons, many of which have nothing to do with the relative ability of the athletes in question. Many times, the flow of choreography, or formations, dictates changes that need to be made in which athletes are doing certain skills. While you are always free to ask the coaches (at appropriate times) to explain any of their decisions, making demands or threats, regarding placement are never warranted and may result in the immediate dismissal of the athlete from the program.

Athletes may be removed from our program at any time for reasons which may include, but are not limited to: attitude problems, absences and/or tardiness, lack of improvement, loss of skills that were originally tried out with, lack of financial responsibility, and personality conflicts between athletes, coaches, parents, or anyone else involved in our program. NO REFUNDS of tuition or fees will be given should an athlete be removed from a team, and all balances of annual fees including tuition will still be due in full.

ARRIVAL AND PICKUP

Be sure your student arrives 5 minutes before (no earlier please) his/her scheduled class/practice time. Please pick up your student on time. Please inform us if you know you will be late picking up your student. Instruct your student to wait inside the building and you should escort them from the building to your car. During peak times the parking lot is crowded. Please take into consideration that our students may include young children. Please drive slowly and carefully. Do not take a chance on your student running to and from your car.

FINANCIAL OBLIGATION

1. I realize that my monthly tuition is due by the first of each month and that I will not be prorated for any vacations or time off. If my payments are made after that due dates, I will be charged a \$25 late fee. There will also be a \$30 fee for all returned checks and possibly legal fees to collect past due balances.

2. If I schedule a private and fail to show up, I will be charged a no-show fee of \$10.
3. I, being 18 years of age or older, do for myself or on behalf of my child participant, if said is a minor, do hereby release, forever discharge and agree to hold harmless Ultimate Cheer and Dance Inc., their owners, directors, coaches and any employees thereof from any and all liabilities, claims, or demands of personal injury, sickness, or death as well as property damage and expenses of any nature whatsoever which may be incurred while in the facilities or on any trips due to competitions or performances.

Furthermore, I fully understand the risks associated with the usage of any and all equipment, class participation, and risks involved during performances and competitions. I (or on behalf of my minor

child participant) hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in classes, at performances and any all competitions. The undersigned further hereby agrees to hold Ultimate Cheer and Dance Inc. harmless, as a result of the negligent and willful or intentional acts of said participant, including expenses incurred attendant hereto.

I hereby grant permission to any licensed hospital and/or doctor to administer immediate medical treatment as deemed necessary to my child should they be injured at any time during summer camp practice, competitions, trips, and all other events related to the team. I understand that I am responsible for payment of expenses incurred relating to my child's participation in these events.
